This program encompasses a variety of non-invasive, as well as invasive, technologies and tools designed for children suffering from drug-resistant epilepsy. Many children with drug-resistant epilepsy are on the autism spectrum, suffer from mood disorders or have cognitive impairments. These vulnerable young people have complex medical needs and not only require but deserve innovative care.

Transcranial Magnetic Stimulation (TMS) is a non-surgical treatment that uses magnetic currents to regulate brain functions in order to reduce seizures. It can also help map brain functions and help determine differences between neurotypical children and those with neurodevelopmental disabilities, which can assist in establishing precision-care medicine. This technology has far-reaching applications including neurorehabilitation after brain trauma, movement disorders, as well as for psychiatric disorders.

The CHU Sainte-Justine hospital finds itself in a unique position to be able to offer this innovative technology to the children of our province. This year's AHEPA Family Annual Saint Valentine's Ball campaign will focus on this innovative TMS technology, thereby adding to Sainte-Justine's existing armamentarium, to encompass the most comprehensive Pediatric Neuromodulation Program in the country.
